

Virgin Islands Republican Caucus, March 10, 2016

Instructions for Casting an Absentee/Offsite Ballot

Under the approved Caucus Rules eligible electors may cast an Absentee/Offsite Ballot for the election of Delegates and Alternates to the Republican National Convention to be held in Cleveland, Ohio July 18-21, 2016. Eligible electors are limited to persons domiciled in and registered to vote in the United States Virgin Islands and being officially registered in the Republican Party as provided in Title 18 of the Virgin Islands Code.

These instructions must be followed in the preparation and submission of such a ballot. Material failure to conform to these instructions will result in the ballot being disregarded.

1. Obtain an approved Absentee/Offsite Ballot and an Absentee/Offsite Ballot Verification Form. These forms can be downloaded and printed from the website of the Republican Party of the United States Virgin Islands (<http://www.usvigop.org/>).

2. Mark one ballot and place it in a plain sealed envelope. Do not place any extraneous marks, words, or lettering on the ballot. Do not place any other papers or items in the envelope other than the marked ballot.

3. Complete and sign an approved Absentee/Offsite Ballot Verification Form (Appendix 2(c) of the Caucus Rules). All information provided in the Verification form shall be declared to be true under penalty of perjury under Virgin Islands law. All requested information must be filled in. Failure to provide all requested information or failure to have your information properly declared and executed under penalty of perjury shall result in your ballot being disregarded.

5. Attach to the Verification form a photocopy of a valid government issued photo identification card bearing the name of the elector as shown on the Verification Form.

4. Place the previously sealed ballot, the Verification Form, and the photocopy of photo identification in a second sealed envelope.

5. By March 9th, (earlier if possible), mail the Ballot, Verification Form, and photocopy of photo identification as thus prepared, to:

6. Hand-Delivery: As an alternative to mailing your ballot, you may arrange for the official ballot, Verification Form and photocopy of photo identification to be hand delivered to the Caucus Site in your District prior to 6:00 p.m. on March 10, 2016.
