ⁱ This letter replaces the notification contained in my correspondence to you of March 21, 2016, which did not contain the names of those persons elevated to fill vacancies in the offices of alternate delegate.

ⁱⁱ Each delegate is in full compliance with Rule 11, which required a duly elected delegate or alternate delegate to submit a written declaration accepting his or her election and confirming his or her willingness to serve on or before the end of the fifth day (March 16, 2016) after final certification by the Certification Subcommittee on March 11, 2016.

ⁱⁱⁱ In accordance with Rule 11, a number of delegates were automatically disqualified for not providing the written declaration within the five-day period required under the rule. Additionally, several others were in violation of Rule 3, which limits "participation ... to persons domiciled in and registered to vote in the Virgin Islands" as defined by Title 18 of the Virgin Islands Code.
